Faults

- over-brided (per maneuver)
- out of frame (per maneuver)
- each hit, bite or stepping on a log, cane, plant or any component of the obstacle
- break of gait at walk or trot for 2 strides or less
- both front or hind feet in a single-stride slot or space at a walk or trot
- stepping over or failing to step into required space
- split pole inlope-over
- incorrect number of strides, if specified
- 1 to 2 steps on mount/dismount or ground tie except shifting to balance
- wrong lead or out of lead for 2 strides or less

Faults

- break of gait at walk or trot for more than 2 strides
- break of gait at lope, except when connecting an incorrect lead
- wrong lead or out of lead for more than 2 strides
- shaped reins (per maneuver)
- 3 to 4 steps on mount/dismount or ground tie
- trotting for more than 3 strides in lope departure or exiting a rollback
- knocking over or severely disturbing an obstacle
- stepping out of or falling off an obstacle with 1 foot
- missing or evading a part of leg obstacle with 1 foot

Faults

- spilling in front of circle
- blatant disobedience (kick, bite, buck, rear, etc.) for each refusal
- use of either hand to touch horseface
- stepping out of or falling off an obstacle with more than 1 foot
- dropping an object required to be carried
- 1st or 2nd cumulative refusal
- letting go of gate
- 5 or more steps on mount/dismount or ground tie
- missing or evading a part of leg obstacle with more than 1 foot

OII Pattern (OPI) - to be placed below horses performing all maneuvers

- eliminates or adds maneuver
- incomplete maneuver
- 3rd refusal
- repeated blatant disobedience
- failure to daily and remain dallyed during the drug
- use of two hands (except junior and L1 horses shown in a mafie ou/lockenou), more than one finger between split reins or any fingers between normal reins (except in the two rein)
- failure to open and shut gate, or failure to complete gate

Disqualified - DQ

- lameness
- disrespect or misconduct
- illegal equipment
- willful abuse
- leaving working area before pattern is complete
- improper western attire
- fail of horseholder

1 Point Penalties:

- Enters, sits, or stepping on, along, over, past or any component of the obstacle
- Increases or breaks off tail at least 6 inches or less
- Bits/band or head/bell in a single white space of a neck or tail.
- Stepping over or failing to step into required space
- Incorrect number of strides, if specified
- One to two steps on demand or groundline except shifting to balance
- Split pole at slope
- Over-headed (not measured)
- Out of Frame (not measured)
- Wrong lead or out of lead by less than 2 strides
- 2 Point Penalties:**
- Moving tail or out of lead for more than 2 strides
- Dragging
- Break of gait at Lope
- Break of gait at Walk or Trot for more than two (2) strides
- 3-4 steps on demand or groundline
- Dragging more than 2 strides in alope departure or failing to collect into a slope

3 Point Penalties/Cont'd:

- Knocking down or over, or severely disturbing an obstacle
- Stepping out of or taking off of an obstacle with one foot
- Abusing or abusing part of a leg/obstacle that is part of a series of obstacles with one foot
- 5 Point Penalties:**
- Spurting in front of coach
- Bitless disobedience
- Use of either hand to instill fear/trust
- Knocking over, stepping out of, or taking off of an obstacle with more than one foot
- Dragging an object required to be carried
- 1st or 2nd consecutive refusal
- Letting go of girth
- 5 or more steps on demand or groundline
- Missing or abusing part of a leg/obstacle that is part of a series of an obstacle with more than one foot

8-Point ID/P:

- Breaking pattern
- Repeated violent disobedience
- Use of two hands (in capture, switch bit or kickdown)
- Missed fences longer than split rails or any longer between rail rails (except two rails)
- SBC
- Laziness
- Abuse
- Illegal equipment
- Challenged or misbehaved
- Leaving arena before pattern is complete

- incorrect number of strides, if specified
- 1 to 2 steps on mound/diamond or ground tie except shifting to balance
- wrong lead or out of lead for 2 strides or less

2. Faults

- break of gait at walk or trot for more than 2 strides
- break of gait at lunge, except when correcting an incensed lead
- wrong lead or out of lead for more than 2 strides
- stepped reins (per maneuver)
- 3 to 4 steps on mound/diamond or ground tie
- trotting for more than 3 strides in lunge departures or exiting a rollback
- knocking over or severely disturbing an obstacle
- stepping out of or falling off an obstacle with 1 foot
- missing or evading a part of log/obstacle with 1 foot
- 5 or more steps on mound/diamond or ground tie
- missing or evading a part of log/obstacle with more than 1 foot

Off Pattern (OP) - to be placed below horses performing all maneuvers

- eliminates or ends maneuver
- incomplete maneuver
- 3rd refusal
- repeated blatant disobedience
- failure to stay and remain dialed during the drag
- use of two hands (except junior and L1 horses shown in a snaffle bit/hackamore), more than one finger between split reins or any fingers between normal reins (except in the two reins)
- failure to open and shut gate, or failure to complete gate

Disqualified - D Score

- lameness
- disrespect or misconduct
- illegal equipment
- willful abuse
- leaving working area before pattern is complete
- improper western attire
- fall of horse/rider

1 First Page Here

- Each H, W, or stepping on a log, cone, plant or any component of the obstacle
 - Inurred in break of pull at walk or trot for more than 2 strides or less
 - Both front or hind legs in a single-wide space at a walk or trot
 - Stepping over or failing to step into required space
 - Inurred number of strides, if specified
 - One or two steps on an obstacle or ground line except shifting to balance
 - Splitgate atlope
 - Over-hindleg (per measured)
 - Out of Frame (per measured)
 - Wrong lead or end of lead for less than 2 strides

3 Point Penalties:

 - Wrong lead or end of lead for more than 2 strides
 - Dropped reins
 - Break of gait at Lope
 - Break of gait at Walk or trot for more than two (2) strides
 - 3-4 steps on an obstacle or ground line
 - Trotting more than 3 strides in a lopé departure or veiling an rollback into a lopé

3 Point Party LineCast™

- Knocking down or over, or severely disturbing an obstacle
 - Clipping out or falling off an obstacle with one foot
 - Knocking or breaking part of a leg/obstacle that is part of a series of obstacles with one foot

- Breaking patient
 - Repeated patient dissatisfaction
 - Use of two hands (except in split wire or backbend)
 - More than one finger between split wire or any fingers between round wire (except two)

DO:

 - Correctness
 - Accuracy
 - Right equipment

 - Leaving wire before patient is complete
 - Improper wedges/needles
 - Full of horseplay
